Madam,

I am directed to refer on State Election Commission's letter No.SEC/2Me/2010/115, dated 27/01/2010 on the subject noted above and to say that General Election of Panchayati Raj Institutions and Municipalities are due in the month of April/May, 2010. The State Election Commissioner, Haryana has issued programme for preparation of electoral rolls of Municipal Corporation, Faridabad, 10 Municipal Councils and 28 Municipal Committees vide its notification 23.1.2010(copies already sent). As per programme, the process for preparation of draft electorals rolls shall be commenced from 25.1.2010. The draft electoral rolls shall be published on 10/02/2010 and subsequent claims and objections shall be received by the Revising Authority concerned by 20.2.2010. The final publication of electoral rolls shall be done on 22.3.2010. The programme for preparation of Voters list for election of Panchayati Raj Institutions is being issued very shortly. After completion the work of voters list/electoral rolls of these institutions, election programme shall be issued by the Commission and the entire process is likely to be completed by 31.5.2010.

I am further directed to request you to ensure that no officers/officials of the State Government posted in district concerned, who are connected with the preparation of electoral rolls and election to the Panchayati Raj Institutions and Municipalities including supporting staff officers/officials of the concerned Municipalities and PRIs have been transferred uptill 31.5.2010. In such cases, where it is considered necessary to transfer any officer connected with the preparation of electoral rolls and election of these Institutions, approval of the State Election Commission may be obtained. Instructions in this regard may kindly be issued to all Head departments of the State Government under intimation to the State Election Commission.
