Ban on posting/transfer of officers/officials who are engaged in Panchayat Bye Elections to be held in month of December, 2010.

Sir,

I am directed to refer to the subject cited above and to say that the State Election Commission, Haryana has issued notification No.SEC/3E-II/2010/7861, dated 26.11.2010 (copy enclosed) for the conduct of Panchayat Bye Elections of the offices of Panches and Sarpanches and Members of Panchayat Samitis in the State on 15.12.2010. The counting of votes in respect of Panches and Sarpanches shall be held immediately after the close of poll and in respect of Member Panchayat Samitis, it shall be held on 16.12.2010 at Block Headquarter.

- 2. I am further directed to inform you that following officers/officials of the State Government posted in the Districts are connected with the conduct of Panchayat Bye Elections:-
 - (i) The Deputy Commissioners/Additional Deputy Commissioners/Sub-Divisional Officers (Civil)/City Magistrates/District Development & Panchayat Officers/Duty Magistrates/Tehsildars/Naib Tehsildars/Block Development and Panchayat Officers etc. and such other officers of the Panchayati Raj Institution entrusted with the work connected with the elections.
 - (ii) The officers appointed as Supervisory Officers.
 - (iii) Officers/officials appointed as Presiding Officers, Polling Officers, Counting Supervisors, Counting Agents and other staff posted for conduct of elections and counting of votes.
 - (iv) Commissioner of Police/Joint Commissioner of Police/Deputy Commissioner of Police/ Assistant Commissioner of Police / Superintendents of Police/Deputy Superintendents of Police/Assistant Superintendents of Police and other Police Officers like Inspector, SHO, Police Station In-charge, Head Constable & Constable who are entrusted with the task of maintenance of law and order and peaceful conduct of elections.
- 2. In view of the position explained above, I am further directed to request you that the above mentioned officers connected with the work of Panchayat Bye Election should not be transferred till the declaration of election results. However, in the cases where it is considered necessary to transfer an officer connected with the above said Panchayat Bye Election, prior approval of this Commission be obtained.

Necessary instructions in this regard may kindly be issued to all the Departments, Boards, Corporations etc. of the State Government under intimation to the State Election Commission, Haryana.
