However, in the cases where it is considered necessary to transfer an officer/official connected with the above said Panchayat Election, prior approval of this Commission be obtained.
- 3. Necessary instructions in this regard may kindly be issued to all the Departments, Boards, Corporations etc. of the State Government under intimation to the State Election Commission, Haryana.
