Subject:- Ban on posting/transfer of officers/officials who are engaged in Panchayat Elections to be held in month of June, 2012.

Sir,

I am directed to refer to the subject cited above and to say that the State Election Commission, Haryana has issued notification No.SEC/3E-II/2012/1113, dated 30.05.2012 (copy enclosed) for the conduct of Bye Elections of the vacant seats of Panches, Sarpanches and Members Panchayat Samitis in the State of Haryana and third General Election of Gram Panchayat Hassanpur, in district Palwal shall be held on 17.06.2012. The counting of votes in respect of Panches and Sarpanches shall be held immediately after the close of poll at the polling stations and in respect of Member Panchayat Samitis, it shall be held on 18.06.2012 at Block/District Headquarter.

2. In view of above, I am further directed to request you that the officers/officials connected with the work of Panchayat Election should not be transferred till the declaration of election results. However, in the cases where it is considered necessary to transfer an officer/official connected with the above said Panchayat Election, prior approval of this Commission be obtained.

3. Necessary instructions in this regard may kindly be issued to all the Departments, Boards, Corporations etc. of the State Government under intimation to the State Election Commission, Haryana.
