Subject:- Ban on posting/transfer of officers/officials who are engaged in Panchayat Bye Elections to be held in month of July, 2013.

Sir,

I am directed to refer to the subject cited above and to say that the State Election Commission, Haryana has issued notification No.SEC/3E-II/2013/16930, dated 11.07.2013 (copy enclosed) for the conduct of the Panchayat bye -elections on the vacant seats of Panches, Sarpanches of Gram Panchayat and Members Panchayat Samitis in the State of Haryana shall be held on 31.07.2013. (Except Faridabad) The counting of votes in respect of Panches and Sarpanches shall be held immediately after the close of poll at all the polling stations and in respect of Member Panchayat Samitis, it shall be held on 01.08.2013 at Block Headquarter concerned.

2. In view of above, I am directed to request you that the officers/officials connected with the work of Panchayat Bye Election should not be transferred till the declaration of election results. However, in the cases where it is considered necessary to transfer an officer/official connected with the above said Panchayat Bye Elections, prior approval of this Commission be obtained.

3. Necessary instructions in this regard may kindly be issued to all the Departments, Boards, Corporations etc. of the State Government under intimation to the State Election Commission, Haryana.
