Subject:-

Election of Panchayat Samiti and Zila Parishad, 2010--Safe custody of ballot boxes after poll.

Sir/Madam,

I am directed to refer to the item No. 13(2) of page 49 of chapter 18 of the Hand Book for Presiding Officer and to request you to follow the instructions strictly in the ensuing general election of Panchayati Raj Institutions also.

- 2. As you are aware that counting of votes of Panchayat Samiti and Zila Paishad will took place on 14.06.2010, therefore to keep safe custody of ballot boxes after poll, the State Election Commission further directs that:-
 - (i) All Presiding Officers or Collecting parties should deposit the ballot boxes, election papers and materials at the storage centers duly specified by the District Election Officer (Panchayat) without any delay. Any officer who defaults in this respect will make himself liable to disciplinary action.
 - (ii) You should earmark inside the storage room or building, specified parts of the floor space in the form of squares in advance for stacking the ballot boxes received from particular polling stations. The arrangements for this should follow the serial numbers of polling stations.
 - (iii) All ballot boxes received from one polling station must invariably be kept together at one place on the same square. The ballot paper account and the paper seal account of each polling station should be kept on top of the ballot boxes pertaining to the polling station.
 - (iv) Sufficient space should be left between rows of ballot boxes as they are being stacked so that other boxes received subsequently out of turn(from the point of view of serial numbers of the polling stations) may be kept at their appropriate allotted space without

the necessity of having to shift any of the ballot boxes received and stacked earlier in point of time.

- It should be ensure that immediately after all the ballot boxes have been received and (v) stored, the room is locked and sealed forthwith. If any of the contesting candidates so desires, he may be permitted to post an agent to keep watch at the place where the ballot boxes are stored pending the counting. Each candidate may be permitted to nominate agents not exceeding three for this purpose. However, only one of such agents will be allotted to be present for keeping watch at any given point of time. The candidate should specifically authorize one of the three agents to affix his seal (in addition to the seal that may be affixed by you) on the doors and windows of the storage place, in case the candidate or the election agent himself is not putting such seal. The candidates should give full particulars of the agents so authorized by them in order to facilitate the verification of their identity. There will be no objection if you or the police authorizes, under whose charge the storage centre is kept, get the photograph of such agents taken at government expense. In order to avoid overcrowding near the storage place and as a measure of safeguard against any possible damage to storage place, the agents keeping vigil may be kept at a reasonable distance from the storage place. But they should be kept at such a place from where they have clear and unhindered view of the storage room/hall so that there is no allegation that they could not keep proper watch of the storage place.
- (vi) It should be ensured that after the storage room/hall is locked and sealed, no one is allowed to go in till the morning of the day & time fixed for counting. If during this interval, for some unavoidable reasons, the room has to be opened, you should send for the candidates or their authorized representatives and open the room in their presence and immediately after the purpose for which the room is opened is over, the room should be locked and sealed again. The candidates or their representatives should again be allowed to seal the door and windows.
- (vii) There should a logbook at every storage centers. In the logbook the name and address of the person, purpose of entry, time of entry, time of exit should be entered alongwith the signature of the guards in the presence of a responsible official. The entry should be with proper permission of Returning officer concerned. Those officer(s) who visit to

inspect the position of the storage center should also sign the logbook alongwith date &

time and record their observation.

(viii) A team of senior officers including Police Officer shall be constituted by the Deputy

Commissioner-cum-District Election Officer(Panchayat) who shall visit the storage

centers minimum two times morning and evening daily.

(ix) Necessary fire fighting equipments around all strong rooms will be provided.

(x) After poll, two tier security for strong rooms shall be provided.

(xi) Deputy Commissioner-cum-District Election Officer(Panchayat) and Superintendent of

Police will be responsible for any lapse in arrangements and security of ballot boxes.

(xii) The proper arrangements for counting of votes of Panchayat Samitis and Zila Parishad to

be held on 14.06.2010 should be made. If you are satisfied and feel necessity of

barricading for this purpose, then the same may be got done but it may be ensured that

the minimum possible expenditure is incurred on the barricading.

(xiii) According to the instructions issued by the Commission (1) the metal seal of the

Presiding Officer and (2) the arrow cross mark rubber stamp for marking the ballot

papers used at the polling station will be put by the Presiding Officer inside the second

bigger envelope containing non statutory items. Before placing them inside the bigger

envelop, these items of election materials should be first put inside separate envelops

on the outside of which the names of the articles should be super scribed and you

should arrange to collect the packets containing these articles and deliver them as soon

as may be practicable after the poll to the District Election Officer (Panchayat) for safe

custody. These articles, after they are returned by the Presiding Officers and duly

accounted for, can be used at any subsequent election, if still serviceable.
