No. SEC/3E-II/2011/3813:- Whereas the State Election Commissioner, Haryana vide its notification No. SEC/3E-II/2011/3691 dated 23.11.2011 has issued the time schedule for the conduct of bye election of Panchayati Raj Institutions in the state of Haryana. Subsequently the bye election of the seat of Sarpanch of Gram Panchayat, Bhaiswal Kalan Mithan ,Block Gohana, District Sonipat, is also scheduled to be conducted on 11.12.2011.

2. And, whereas, the Deputy Commissioner-cum-District Election Officer (Panchayat) Sonipat on the report of Senior Superintendent of Police, Sonipat has informed vide its memo no. 6932/Panchayat dated 30.11.2011 that due to election tussle in the village, Sh. Mukesh, Sarpanch, of the said Gram Panchayat was murdered on 8.5.2011, subsequently four murder has been occurred in the same village and further informed that due to tense atmosphere of the village it would not be possible to hold bye election on 11.12.2011 in a peaceful manner and further recommended to postpone the bye election for the period of four to six months.

3. In view of the above, the State Election Commission, Haryana hereby orders to postpone the bye election of the seat of Sarpanch of Gram Panchayat, Bhaiswal Kalan Mithan, Block Gohana, District Sonipat, till further orders.
