The State Election Commission, Haryana vide notification No. SEC/3E-II/2015/10233, dated 15<sup>th</sup> December, 2015 has issued the election programme for the conduct of elections of Panchayati Raj Institutions in the State of Haryana. In TABLE-C of para 5 of the notification, the list of blocks to be included in 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> phase has been given.

2. District Election Officer (P), Palwal vide Memo No. 4813/Panchayat dated 21.12. 2015 has submitted that in view of the report of Returning Officer (P) –cum-S.D.O (c ), Hodel, the election of block Hassanpur may be conducted in 3<sup>rd</sup> phase as fresh reservation of Gram Panchayats is yet to be made as per the orders of Hon'ble Punjab and Haryana High Court passed in CWP No. 11595 of 2015.

3. In view of the request of the District Election Officer (Panchayat), Palwal, the Commission hereby modify the list of blocks of the district (Sr. No. 16 of TABLE-C ) at para 5, as under : -
