The Commission vide Notification No. SEC/4E-II/2015/5534 dated 18th May, 2015 has issued the notification for the preparation of voter lists of Panchayati Raj Institution in 17 districts Sonapat, Yamuna Nagar, Sirsa, Panchkula, Faridabad, Palwal, Kaithal, Rohtak, Fatehabad, Hissar, Panipat, Narnaul, Rewari, Mewat, Kurukshetra, Jind and Jhajjar, where the work of wardbandi had been completed. As per programme, the final publication of the voters list is to be made on 15.07.2015.

Now, this Commission has received requests from the Deputy Commissioner-cum-District Election Officer (P), Palwal, who has intimated that on 05.07.2015 communal violence had taken place in village Tikri Brahman of the district and the Administrative Officers/Officials were deputed to maintain peace in the area. Resultantly, the work w.r.t. the preparation of voters list has badly been effected and it not possible for them to finally publish the voters list on 15.07.2015. The request has therefore been made to extend the date of final publication in public interest.

In view of the request of Deputy Commissioner-cum-District Election Officer, Palwal, the State Election Commission, Haryana in accordance with the provisions contained in Section 163, 164, 165 and 166 of the Haryana Panchayati Raj Act, 1994 read with Rules 8, 9, 9A, 10, 10A, 11 and 12 of the Haryana Panchayati Raj Election Rules, 1994 and powers conferred under Sub-Section (1) of Section 212 of the Haryana Panchayati Raj Act, 1994, hereby extends the voters list time schedule in respect of district Palwal from the stage of final publication of voters list and amend the relevant part of Notification(referred to above), as under: -
