No. SEC/4E-II/2018/1132: Whereas, programme for the Bye elections of Panchayati Raj Institutions was issued vide Commission's Notifications No.SEC/4E-II/2018/1030, dated 08.08.2018. According to which nominations were to be filed between 17/08/2018 to 23/08/2018 and poll was to be held on 02.09.2018.

- 2. Whereas the State Govt. vide its order No.16/1/2003-2POL, dated 16.08.2018 has declared holiday on 17.08.2018 under Negotiable Instrument Act, 1881 due to sudden demise of Sh.Atal Bihari Vajpayee ji, former Prime Minister of India.
- 3. In view of the above the Commission has decided to reschedule the programme for bye elections as given under:-

6.	Date on which symbols shall be allotted to the contesting candidates.	27.08.2018 (After 3.00 PM)
7.	Date on which the list of contesting candidates shall be pasted under Rule 24(2)(v).	27.08.2018 (immediately after the allotment of symbols)
8.	Date on which the poll, if any, shall be held under Rule 24(2) (vi).	04.09.2018 (Tuesday)
9.	Timing of the poll	Between 8.00 A.M. to 4.00 P.M.
10.	Counting of votes	i) Immediately after the close of poll. ii) In case of re-poll, the Commission may change the date and time of counting of votes.
