- 2. The above rates are also applicable to the staff for attending training classes, collecting polling materials, etc., and also for attending duty on the polling day.
- The staff deployed at all polling stations/counting centers shall be provided with packed lunch and or light refreshment at the rate of Rs.150/- per head per day. In case of difficulty in providing packed lunch, a cash payment of Rs.150/- per head shall be made.
- 4. The police personnel deployed on election work for Polling/Counting day including Mobile Parties/Home Guards/Forest Guards/Gram Rakshak Dal/NCC(Senior) Cadets /Ex- Army/CPF shall be provided with packed lunch/refreshment or payment in lieu thereof as is being given to polling /counting personnel.
- These orders shall supersede Commission's order No. SEC/1-Accounts/2010/200-220, 5. dated 30-04-2010 and letter No. SEC/1-Accounts/2011/1769-89, dated 14-09-2011.
- These orders shall be applicable from the date of its issuance.
