Monitoring of New Pension Scheme (NPS) - Regarding release of NPS contributions & missing credits after final withdrawal processed by CRA-NSDL, Mumbai.

Sir/Madam

I am directed to invite your attention towards Finance Department's letter No. 2/47/2007-1 Pension, dated 23.07.2012 and dated 5.11.2012 wherein the detailed guidelines for withdrawal of pension corpus under NPS on superannuation and on death as well as other than superannuation had been issued.

(PFRDA) has issued Exit & Withdrawals policy under New Pension Scheme Regulation, 2015. The clause - 37 of NDS Parallel 2017 Regulation, 2015. The clause – 37 of NPS Regulation-2015 specify (for) stopping of last three months NPS contribution of subscribers before his/her date of superannuation for smooth and effective withdrawal process of the subscribers.

It has been brought to the notice of the State Government that there are cases where amount has been deducted from salary bill of NPS subscribers but could not be upleaded with subscribers but could not be uploaded within prescribed period due to various reasons like non-receipts from concerned DDO, DA arrears, revision of pay due to Court directions, promotion from retrospective date etc. in which there is legacy amount pending and in the meanwhile final withdrawals request has also been processed (online) by CRA-NSDL Mumbai.

> To overcome the above difficulty, the State Government has decided to follow the following procedure in such cases:-

- a. The employee/subscriber contribution shall be deposited by the DDOs concerned through e-billing under the major Head of the Department concerned by Book Transfer under Major Head - 8342, if not deducted from regular salary bills.
- b. The employer/Government contribution shall be deposited by Treasury Officer concerned by preparing bills under Major Head 2071 in equal

amount of employee's contribution which will be transferred through Book Transfer from Major Head 2071 to 8342 in usual way.

c. For both the amounts (of Sr. No a & b above), the Treasury Officer will prepare bill under Major Head 8342 and transfer to the employee under his/her Unique code of Payee(UCP) on the last day of retirement or so (as the case may be). UCP will be provided by DDO concerned.
