NOTIFICATION

**No.SEC/1ME/2005/21194:** The State Election Commissioner in exercise of powers vested under clause (1) of Article 243ZA of the Constitution of India, Section 3A of the Haryana Municipal Act, 1973 and Rule 19(1) of the Haryana Municipal Election Rules, 1978 and all other powers enabling him in this behalf, has prescribed the election programme for the conduct of election in all the wards of 20 Municipal Councils and 27 Municipal Committees vide Notification No.SEC/1ME/2005/18000, dated the 15<sup>th</sup> March, 2005, according to which the last date for making application for the revision of Order of the Authority scrutinizing the nomination paper to the Deputy Commissioner was 01.04.2005.

Now, the State Government has declared 01.04.2005 as a Holiday on account of death of two Cabinet Ministers in Haryana.

In view of above, in exercise of powers vested under clause (1) of Article 243ZA of the Constitution of India, Section 3A of the Haryana Municipal Act, 1973 and Rule 19 (7) of the Haryana Municipal Election Rules, 1978 and all other powers enabling me in this behalf, I, Chander Singh, State Election Commissioner, Haryana hereby amends the election programme for conduct of election in all the wards of 20 Municipal Councils and 27 Municipal Committees to the effect that the last date for making application for the revision of Order of the Authority scrutinizing the nomination paper to the Deputy Commissioner under Rule 19(2)(iv) will now be 02.04.2005 instead of 01.04.2005. Therefore, no revision application shall now be received on 01.04.2005 by the Deputy Commissioner due to Holiday declared by the State Government.

The other election programme shall remain unchanged.
