**NOTIFICATION**

**Dated, the 25<sup>th</sup> November,2004**

No.SEC/2ME/2004/12765:-Where as the State Election Commission, Haryana issued a programme for preparation of Electoral Rolls of all the wards of the 20 Municipal Councils and 27 Municipal Committees intensively on the basis of Assembly Electoral Rolls finally published on 23.02.2004 with reference to 1st January, 2004 as qualifying date vide its notification No.SEC/2ME/2004/10036, dated 28.09.20-04, according to which the final publication/printing of Electoral Rolls of these municipalities was to be done on 18.11.2004. The final publication of Municipal Council, Ambala Sadar, Municipal Council, Fatehabad, Municipal Council, Tohana, Municipal Council, Jind, Municipal Committee, Ratia, Municipal Committee, Mahendergarh, Municipal Committee, Charkhi Dadri, Municipal Council, Narnaul, Municipal Council, Narwana, Municipal Committee, Gohana and Municipal Committee, Safidon has been done on 18.11.2004.

And whereas the State Election Commission, Haryana vide its notification No.SEC/2ME/2004/12410, dated 18.11.2004 extended the date of final publication/printing of Electoral Rolls for a period of one week from 18.11.2004 and accordingly final publication of Electoral Rolls was to be done on 25.11.2004. The final publication of Municipal Council, Rewari, Municipal Council, Sonipat, Municipal Committee, Traori, Municipal Council, Panipat,

Municipal Committee, Samalkha and Municipal Committee, Ellenabad has been done on 25.11.2004.

And whereas M/s Swastik Printers, Gurgaon and Deputy Commissioner, Gurgaon has informed telephonically on 24-11-2004 that they are unable to print the Electoral Rolls of the 15 municipalities by 25<sup>th</sup> November, 2004 due to certain technical problems in their computer systems. They have also shown their inability to do this work.

And whereas Secretary, Municipal Committee Kalka, and Deputy Commissioner, Panchkula vide his Endst. No.Election/Special/2, dated 24.11.2004 and Deputy Commissioner, Hisar vide his letter No. 1637/LFA, dated 24-11-2004 has requested for extention of time for publication/printing of Electoral Rolls from 25.11.2004 to 06.12.2004/07.12.2004 respectively on account of non-completion of printing work by M/s Pragati Press, Delhi and M/s Swastik Printers, Gurgaon respectively.

Now, in view of the above mentioned unavoidable circumstances, the State Election Commission hereby extends the date for final publication/printing of Electoral Rolls in respect of Municipal Councils Gurgaon, Karnal, Narnaul, Hisar, Yamunanagar, Jagadhri, Hansi, Palwal and Rohtak and Municipal Committees Hodal, Firozpur Jhirka, Nuh, Sohna, Jhajjar, Barwala, Bawal, Kalka and Meham from 25.11.2004 to 15.12.2004. Now the final publication of the Electoral Rolls of abovesaid 19 Municipalities shall be done on 15.12.2004 positively.

The other directions issued vide above referred Commission's notification shall remain unchanged.
