Whereas the Haryana Government in Development & Panchayats Department by its notification No. SA/HA-II/94/S-211/2000, dated 21/02/2000 in exercise of powers conferred by Sub-Section (1) of Section 211 of the Haryana Panchayati Raj Act, 1994 (Act 11 of 1994) and all powers enabling it in this behalf and in supersession of Haryana Government, Development & Panchayats Department obligation No. S.O./209/H-A-11/94/S-211/99, dated 28th September, 1999 directed that General elections of Panches and Sarpanches of Gram Panchayats and Members of Panchayat Samitis and Zila Parishads shall be held and made in the State of Haryana by 31st March, 2000 as specified by the State Election Commission.

Now, therefore, in exercise of powers vested under clause (1) of Article 243 of the Constitution of India and under Rule 24 of the Haryana Panchayati Raj Election Rules, 1994 and all other powers enabling me in this behalf and in pursuance of provisions contained in Sub-Section (1) and (2) of Section 161 and Sub-Section (2) of Section 211 of the Haryana Panchayati Raj Act, 1994, I T.D.Jogpal, State Election Commissioner, Haryana hereby prescribe the time schedule for the conduct of General elections to Panchayats i.e. for Panches, Sarpanches, Members of Panchayat Samitis and Zila Parishads. The time schedule as prescribed is given below:-
