I am directed to say that the State Election Commission, Haryana has since declared the Municipal General Elections to all wards of 15 Municipal Councils Charkhi Dadri (Bhiwani), Kaithal (Kaithal), Hansi (Hisar), and Fatehabad (Fatehabad), (Mahendergarh), Tohana Sohna (Gurgaon), Bahadurgarh (Jhajjar), Narwana & Jind (Jind), Thanesar (Kurukshetra), Hodal & Palwal (Palwal), Mandi Dabwali (Sirsa), Gohana (Sonipat) and 28 Municipal Committees i.e. Naraingarh (Ambala), Cheeka & Rajound (Kaithal), Barwala (hisar), Mahendergarh & Nangal Chaudhary (Mahendergarh), Samalkha (Panipat), Bhuna & Ratia (fatehabad), Jhajjar (Jhajjar), Safidon & Uchana (Jind), Tarori, Nissing, Gharunda & Assandh (Karnal) Ladwa, Pehowa & Shahabad (Kurukshetra), Ferozepur Zhirka, Nuh & Punhana (Mewat), Bawal (Rewari), Meham (Rohtak), Kalanwali, Ellenabad & Rania (Sirsa) and Ganaur (Sonipat) and bye elections in ward No.9, Municipal Corporation, Panipat, ward No.1, Municipal Council Rewari and ward No.7, Municipal Committee, Kalanaur for holding the poll on 22.05.2016. Copy of Notification No.SEC/1ME/2016/414 & 431, dated 28.04.2016 whereby the election programme has been prescribed for the conduct of general elections and bye elections is enclosed. The nomination for election to the office of members in respect of Municipal General Elections to the above mentioned Municipalities will start from 05/05/2016 and the nomination papers can be filed upto 11/05/2016. The date of scrutiny of nomination papers has been prescribed on 12/05/2016. The last date for withdrawal of nomination papers is 13/05/2016. The poll will be held on 22/05/2016. The counting of votes will take place on the same day.

2. I am further directed to request you that officers/officials of the State Government posted in all the Districts except Faridabad, Panchkula and Yamunanagar who are connected with the conduct of Municipal General/Bye Elections including middle level Revenue Officers like Tehsildar, Naib Tehsildar and Block Development Officers and officers of equivalent status in the Revenue and Land Administration Departments and Police Officers like Sub Inspectors and Assistant Sub Inspector and other equivalent Officers should not be transferred

during the election period and upto the declaration of results. In such cases, where it is considered necessary to transfer any officer connected with the election to the above mentioned Municipal Council/Committee, the approval of the State Election Commission may also be obtained. Instructions in this regard may also kindly be issued to all the departments of the State Government under intimation to the State Election Commission.
