

**STATE ELECTION COMMISSION HARYANA

ORDER

No.SEC/3ME/2019/159

Dated: 05.02.2019

The General Election of Municipal Committee, Dharuhera was held on 25.05.2014 and the result of the elected candidates was declared same day.

2. Section 13E of the Haryana Municipal Act, 1973, provides that every candidate at an election shall, either himself or by his election agent, keep a separate and correct account of all expenditure in connection with the election incurred or authorized by him or by his election agent from the date of filing of nomination papers to the date of declaration of the result thereof, both dates inclusive. The account shall contain such particulars, as may be notified by the State Election Commission in this behalf. The total of the said expenditure shall not exceed such amount as may be notified by the State Election Commission from time to time.

3. Section 13D of the Haryana Municipal Act, 1973 read with Section 10 A of the Representation of People Act, 1951 further provides that if the Election Commission is satisfied that a person –

- (a) has failed to lodge an account of election expenses, within the time and in the manner required by or under this Act, and
- (b) has no good reason or justification for the failure

the Election Commission shall, by order published in the Official Gazettee, declare him to be disqualified and any such person shall be disqualified for a period of three years from the date of the order.

4. In pursuance of the above provisions, the State Election Commission, Haryana vide its notification No. SEC/3ME/2011/2813, dated 05.09.2011 in exercise of powers vested under clause (i) Article 243 ZA of the Constitution of India, sub-section 3 of Section 13E of the Haryana Municipal Act, 1973 had prescribed the limit of expenditure of Rs.50 ,000/- that may be incurred by the contesting candidate or his authorized agent in connection with election of Municipal Committee, Dharuhera and account of election expenses shall be filed/lodged with the Deputy Commissioner or any other officer prescribed by the Commission within 30 days from the date of declaration of the result of election.

5. The State Election Commissioner, Haryana in exercise of powers contained under Section 3B of the Haryana Municipal Act, 1973 authorized Assistant State Election Commissioner, State Election Commission, Haryana vide order No.SEC/1ME/2017/2017, dated 01.12.2017 and further modified vide order No.SEC/1ME/2018/842, dated 28.02.2018 to decide the cases of disqualification of the candidates of the said municipality, who failed to lodge their account of election expenses.

6. As reported by the Secretary, Municipal Committee, Dharuhera, the following candidates had contested the election of Municipal Committee, Dharuhera held on 24.05.2014 but failed to submit their election expenditure account:-

7. The Commission had served a show cause notice upon them to explain as to why they should not be disqualified on account of non submission of election expenditure account within the period. They neither submitted their election expenditure statement nor responded to the show cause notice. I, had given them an opportunity of personal hearing on 28.01.2019 in the office of State Election Commission, Haryana, Nirvachan Sadan, Plot No.2, Sector-17, Panchkula in the interest of natural justice. Sh.Manish, Clerk of Municipal Committee, Dharuhera was appeared who has submitted a copy of letter dated 14.01.2019 issued by the Secretary, Municipal Committee, Dharuhera to all the above said candidates. It has been observed notice of personal hearing has been delivered in person or through their family members. Notice to one candidate mentioned at Sr. No.4 could not be delivered, as he has left Dharuhera.

8. The above mentioned contesting candidates neither appeared before me nor filed any representation. Therefore, it can be concluded that they have nothing to say in the matter. Hence, they are proceeded ex-parte. The above noted candidates deserve to be disqualified. Hence I, Parmal Singh, Assistant State Election Commissioner, Haryana, hereby order that all the above 4 candidates are disqualified under Section 13D of the Haryana Municipal Act, 1973 read with Section 10A of the Representation of People Act, 1951 for being chosen as, and for being a member of Municipality for a period of three years from the date of this order.

9. The office is directed to send a copy of this order to the candidate concerned through Deputy Commissioner, Rewari immediately.

Subject :- Disqualification of Smt.Ramkala, contesting candidate from Ward No.8 of Municipal Committee, Dharuhera.

The General Election of Municipal Committee, Dharuhera was held on 24.05.2014 and the result of the elected candidates was declared on the same day.

2. Section 13E of the Haryana Municipal Act, 1973, provides that every candidate at an election shall, either himself or by his election agent, keep a separate and correct account of all expenditure in connection with the election incurred or authorized by him or by his election agent from the date of filing of nomination papers to the date of declaration of the result thereof, both dates inclusive. The account shall contain such particulars, as may be notified by the State Election Commission in this behalf. The total of the said expenditure shall not exceed such amount as may be notified by the State Election Commission from time to time.

3. Section 13D of the Haryana Municipal Act, 1973 read with Section 10 A of the Representation of People Act, 1951 further provides that if the Election Commission is satisfied that a person –

- (a) has failed to lodge an account of election expenses, within the time and in the manner required by or under this Act, and
- (b) has no good reason or justification for the failure

the Election Commission shall, by order published in the Official Gazettee, declare him to be disqualified and any such person shall be disqualified for a period of three years from the date of the order.

4. In pursuance of the above provisions, the State Election Commission, Haryana vide its notification No. SEC/3ME/2011/2813, dated 05.09.2011 in exercise of powers vested under clause (i) Article 243 ZA of the Constitution of India, sub-section 3 of Section 13E of the Haryana Municipal Act, 1973 had prescribed the limit of expenditure of Rs.50,000/- that may be incurred by the contesting candidate or his authorized agent in connection with election of Municipal Committee, Dharuhera and account of election expenses shall be filed/lodged with the Deputy Commissioner or any other officer prescribed by the Commission within 30 days from the date of declaration of the result of election.

5. The State Election Commissioner, Haryana in exercise of powers contained under Section 3B of the Haryana Municipal Act, 1973 authorized Assistant State Election Commissioner, State Election Commission, Haryana vide order No.SEC/1ME/2017/2017, dated 01.12.2017 and further modified vide order No.SEC/1ME/2018/842, dated 28.02.2018 to decide the cases of disqualification of the candidates of the above said municipality, who failed to lodge their account of election expenses.

6. As reported by the Secretary, Municipal Committee, Dharuhera, Smt.Ramkala, candidate had contested the election from Ward No.8 of Municipal Committee, Dharuhera but failed to submit her election expenditure account within the prescribed time or thereafter. I, had given her personal hearing on 28.01.2019 in the office of State Election Commission, Haryana, Nirvachan Sadan, Plot No.2, Sector-17, Panchkula. Sh.Manish, Clerk of the Municipal Committee, Dharuhera, represented the Deputy Commissioner Rewari. The above said

candidate had not appeared personally and sent her reply through email and submitted the following:-

“Due to illness she could not appear for personal hearing and attached a page of election expenditure register.”

7. On perusal of expenditure register, it has been observed that expenditure register is not verified by any authority neither she disclosed any reason for filing the election expenditure statement beyond the prescribed time limit. I am satisfied that the above said candidate has failed to lodge an account of election expenditure, within the time and in the manner required by or under this Act. Moreover, above said candidate has submitted no good reason or justification for her failure to submit election expenditure account. Hence, she deserves to be disqualified. I, Parmal Singh, Assistant State Election Commissioner, Haryana, under Section 13D of the Haryana Municipal Act, 1973 read with Section 10A of the Representation of People Act, 1951 hereby order that **Smt.Ramkala** is disqualified for being chosen as, and for being a member of Municipality for a period of three years from the date of this order.

8. The office is directed to send a copy of this order to the candidate concerned through Deputy Commissioner, Rewari immediately.
