Whereas, the State Election Commission, vide its notification No. SEC/2ME/2017/1141, dated 02.06.2017 has prescribed a schedule for the distribution of electors of the Legislative Assembly Constituency published on 10.01.2017 with reference to 1st January, 2017 as qualifying date, into the wards and booths of the Municipal Corporation, Gurugram. As per schedule, draft electoral roll has been published on 22.06.2017; last date for filing claims and objections has been fixed 28.06.2017

2. Whereas, the Deputy Commissioner, Gurugram vide its memo No. 21/LB, dated 24.06.2017 has informed that after draft publication of electoral on 22.06.2017, claims and objections were to be filed from 23.08.2017 to 28.06.2017, and in between there were two gazetted holidays and further requested to extend the time for filing the claims and objections by one week.

3. In view of request of the Deputy Commissioner, Gurugram, the State Election Commission, in exercise of powers conferred in Section 3A of the Haryana Municipal Act, 1973 read with rule 4 of Haryana Municipal Election Rules, 1978, hereby revise the schedule for preparation of ward wise and booth wise photo based electoral rolls in respect of all the wards of the Municipal Corporation, Gurugram with reference to 1st January, 2017 as qualifying date as under:-

(i)	Last date by which claims and objections shall be presented to the Revising Authority. [Rule-4(4)(i)]	06.07.2017
(ii)	Last date by which the claims and objections shall be disposed of by the Revising Authority. [Rule-4 (4) (v)& (vii)]	14.07.2017
(iii)	Last date for filing appeals with the Deputy Commissioner against the orders of Revising Authority. (Rule-4 (4) (viii)]	18.07.2017
(iv)	Last date for disposal of appeals by the Deputy Commissioner.[Rule 4(4) (viii)]	21.07.2017
(vi)	Final publication of Electoral Rolls.(Rule-4 (4) (ix)	27.07.2017

4. The Deputy Commissioner, Gurugram shall give wide publicity of the above programme.

5. The remaining instructions issued earlier by notification No. SEC/2ME/2017/1142, dated 02.06.2017 shall remain the same.


