The State Election Commission, Haryana vide Notification No. SEC/2ME/2018/4063 dated 06.07.2018 has issued a programme for the preparation of the electoral rolls of the Municipal Corporation, Yamuna Nagar on the basis of the electoral rolls of respective Legislative Assembly or part thereof finally published on 10.01.2018 with qualifying date as 01.01.2018. programme, the draft rolls of the Municipal Corporation, Yamuna Nagar District

The Deputy Commissioner, Yamuna Nagar vide his memo No. 1032, 2. dated 26.07.2018 has informed that due to late receipt of notification of the Commission for the preparation of electoral roll and technical fault in software draft electoral roll could not be prepared booth wise in short time. He has also informed that the draft electoral roll has been prepared booth wise and the same has been published on 26.07.2018. The Deputy Commissioner has requested to extend the period of filing claims and objections for the convenience of public.

Yamuna Nagar were to be published on 23.07.2018, last date for filing claim and

objections was 28.07.2018 and rolls were finally to be published on 31.08.2018.

In view of request of the Deputy Commissioner, Yamuna Nagar, the State Election Commission, in exercise of powers conferred in Section 9 of the Haryana Municipal Corporation Act, 1994 read with rule 4 of Haryana Municipal Corporation Election Rules, 1994, hereby revise the schedule for preparation of ward wise and booth wise photo based electoral rolls in respect of all the wards of the Municipal Corporation, Yamuna Nagar with reference to 1st January, 2018 as qualifying date as under:-
