The State Election Commission, Haryana vide Notification No. SEC/2ME/2018/402 dated 23.01.2018 has issued a programme for the preparation of the electoral rolls of the sixteen municipalities including Municipal Committee, Beri (Jhajjar) and Kalayat (Kaithal) on the basis of the electoral rolls of respective Legislative Assembly or part thereof finally published on 10.01.2018 with qualifying date as 01.01.2018. As per abovesaid notification, the electoral rolls of these two Committees were required to be prepared on the existing wards, as the process for the delimitation of these committees had not been completed till that time. As per programme, the draft rolls of these committees were to be published on 06.02.2018, last date for filing claim and objections was 12.02.2018 and rolls were finally to be published on 12.03.2018.

- 2. Now, the State Government has completed the delimitation process of all the wards of these committees i.e. Municipal Committee, Beri (Jhajjar) and Kalayat (Kaithal) and necessary notifications in this respect have also been issued vide No. 18/171/2017-3C1 and 18/169/2017-3C1, both dated 07.02.2017 respectively.
- And now, in view of the notifications dated 07.02.2018 referred above, the Commission, Haryana hereby directs to prepare the draft electoral roll of Municipal Committee, Beri (Jhajjar) and Kalayat (Kaithal) by distributing the electors of Assembly constituencies(falls in the area of municipalities) into the revised wards of these municipalities issued by the Govt. The revised schedule for the preparation of electoral rolls of these municipalities is hereby given as under:-
