### NOTIFICATION

NO. SEC/2ME/2018/740

The State Election Commission, Haryana vide Notification No. SEC/2ME/2018/402 dated 23.01.2018 has issued a programme for the preparation of the electoral rolls of the sixteen municipalities including Municipal Committee, Taoru on the basis of the electoral rolls of respective Legislative Assembly or part thereof finally published on 10.01.2018 with qualifying date as 01.01.2018. As per programme, the draft electoral rolls of Municipal Committee, Taoru were published on 06.02.2018, claim and objections were filed from 06.02.2018 to 12.02.2018 and final electoral rolls were to be published on 12.03.2018.

2. Now, the Deputy Commissioner, Mewat vide his letter No. 3024/LFA, dated 23.02.2018 has intimated that Revising Authority, Municipal Committee, Taoru vide his letter No. 23, dated 22.02.2018 has brought into his notice while deciding claims and objections it come his notice that large number of electors of some wards could not be included in the draft electoral roll of the Committee. On the recommendation of Revising Authority the Deputy Commissioner, Mewat has requested to revise the schedule for the preparation of electoral roll of the said Committee.

3. And now, in view of the request of Deputy Commissioner, Mewat, the Commission, Haryana hereby directs to prepare/ publish afresh draft electoral roll of Municipal Committee, Taoru by distributing the electors of Assembly constituencies(falls in the area of municipalities) into the existing wards of the

Municipal Committee, Taoru. The revised schedule for the preparation of electoral rolls of the Municipal Committee, Taoru District Mewat is hereby given as under:-

(i)	Publication of revised draft electoral rolls of all the wards of the municipality for inviting claims and objections [Rule- 4(3)].	27.02.2018
(ii)	Last date by which claims and objections shall be presented to the Revising Authority [Rule-4(4) (i)].	07.03.2018 (Except 02 & 04.03 2018) (Up to 3.00 PM)
(iii)	Last date by which the claims and objections shall be disposed of by the Revising Authority [Rule-4 (4) (v) & (vii)].	13.03.2018
(iv)	Last date for filing appeals with the Deputy Commissioner against the orders of Revising Authority [Rule-4 (4) (viii)]	16.03.2018
(v)	Last date for disposal of appeals by the Deputy Commissioner.[Rule 4(4) (viii)]	20.03.2018 (Except 18.03.2018)
(vi)	Final publication of electoral rolls .(Rule-4 (4) (ix)	26.03.2018

4. The Deputy Commissioner, Mewat shall give wide publicity of the above programme.

5. The remaining instructions issued earlier by notification No. SEC/2ME/2018/402 dated 23.01.2018 shall remain unchanged.
