### NOTIFICATION

The State Election Commission, Haryana vide Notification No. SEC/2ME/2018/4389 dated 20.07.2018 has issued a programme for the preparation of the electoral rolls of the Municipal Corporation, Panipat on the basis of the electoral rolls of respective Legislative Assembly or part thereof finally published on 10.01.2018 with qualifying date as 01.01.2018. As per programme, the draft rolls of the Municipal Corporation, Panipat District Panipat are to be published on 10.08.2018, last date for filing claim and objections are 17.08.2018 and rolls are finally to be published on 14.09.2018.

2. That In view of the administrative reason, the Commission has decided to revise the schedule with regard to the preparation of ward wise and booth wise photo based electoral rolls in respect of all the wards of Municipal Corporation, Panipat with reference to 1<sup>st</sup> January, 2018 as qualifying date and accordingly para No.2 of the above referred notification is modified here as under:-

(i)	The ward wise and booth wise photo based draft electoral rolls of all wards of the Corporation referred to above shall be prepared as per delimitation Notification No. 18/60/2018-3C1, dated 16.07.2018 by distributing the electors of the respective areas of Legislative Assembly or part thereof, into the wards of the Corporation on the basis of latest Assembly electoral rolls published on 10 <sup>th</sup> January, 2018 as qualifying date with reference to 1 <sup>st</sup> January, 2018 as qualifying date with supplements.[Rule -4(1)]. electoral	26.07.2018 To 09.08.2018
(ii)	Publication of draft electoral rolls of all the wards of the Corporation as referred in sub-para (i) above for inviting claims and objections. [Rule-4(3).	10.08.2018 (Friday )
(i)	Last date by which claims and objections shall be presented to the Revising Authority. [Rule-4(4)(i)]	16.08.2018 (Upto 3.00PM) (Thursday)
(ii)	Last date by which the claims and objections shall be disposed of by the Revising Authority. [Rule-4 (4) (v)& (vii)]	24.08.2018 (Friday)

(iii)	Last date for filing appeals with the Deputy Commissioner against the orders of Revising Authority. (Rule-4 (4) (viii))	29.08.2018 (Wednesday)
(iv)	Last date for disposal of appeals by the Deputy Commissioner.[Rule 4(4) (viii)]	01.09.2018 (Saturday)
(vi)	Final publication of Electoral Rolls.(Rule-4 (4) (ix))	07.09.2018 (Friday)

4. The Deputy Commissioner, Panipat shall give wide publicity of the above programme.

5. The remaining instructions issued earlier by notification No. SEC/2ME/2018/4389 dated 20.07.2018 shall remain unchanged.
