The State Election Commission, Haryana vide Notification No. SEC/2ME/2019/582 , dated 27.02.2019 has issued a programme for the preparation of the electoral rolls of the Municipal Corporation, Sonapat on the basis of the electoral rolls of respective Legislative Assembly or part thereof finally published on 31.01.2019 with qualifying date as 01.01.2019. As per programme, the draft rolls of the Municipal Corporation, Sonapat were to be published on 13.03.2019, last date for filing claim and objections was 19.03.2019 and rolls were finally to be published on 15.04.2019.

2. Now, the Deputy Commissioner, Sonapat vide his letter No. 1185/LFA, dated 13.03.2019 has informed that he is a Returning Officer in the Lok Sabha Elections, 2019. For the conduct of these elections all the officers & officials are busy in election work. The Officers/ officials are deputed in election duty till the completion of these elections. The BLOs are presently deputed in Board Exam and Polio programme duties and due to rush of work BLOs are not available for the physical verification of preliminary voter list. As such, any error may be occurred in the preparation of preliminary voter list. No officer/ official is available for the disposal of claims and objections. The request has therefore been made to give time for the conduct of the elections of Municipal Corporation, Sonapat in view of Lok Sabha elections so that the election of Corporation may be conducted smoothly.

3.. And now, in view of the request of Deputy Commissioner, Sonapat , the Commission, hereby directs to revise the schedule for the prepare of electoral rolls of Municipal Corporation, Sonapat from the publication of draft electoral rolls at this time.

(i)	Publication of draft electoral rolls of all the wards of the Corporation for inviting claims and objections [Rule- 4(3)].	14.05.2019
(ii)	Last date by which claims and objections shall be presented to the Revising Authority. {Rule -4(3)}	27.05.2019

(iii)	Last date by which the claims and objections shall be disposed of by the Revising Authority [Rule-4 (4) (v) & (vii)].	04.06.2019
(iii)	Last date for filing appeals with the Deputy Commissioner against the orders of Revising Authority [Rule-4 (4) (viii)]	10.06.2019
(iii)	Last date for disposal of appeals by the Deputy Commissioner.[Rule 4(4) (viii)]	13.06.2019
(iv)	Final publication of electoral rolls .(Rule-4 (4) (ix)	20.06.2019

4. The Deputy Commissioner, Sonapat shall give wide publicity of the above programme.

5. The remaining instructions issued earlier by notification No. SEC/2ME/2019/582 dated 27.02.2019 shall remain unchanged.


