Whereas, the State Election Commission, vide its notification No. SEC/2ME/2017/1167, dated 08.06.2017 has prescribed a schedule for the distribution of electors of the Legislative Assembly Constituency published on 10.01.2017 with reference to 1<sup>st</sup> January, 2017 as qualifying date, into the wards and booths of the Municipal Committee, Barara in Ambala District. As per schedule, draft electoral roll has been published on 22.06.2017; last date for filing claims and objections was fixed 28.06.2017

2. Whereas, the Sub Divisional Officer (Civil), Barara vide its Memo No. Spl.-1/Steno, dated 28.06.2017 has informed that after publication of draft electoral on 22.06.2017, there were holidays from 24.06.2017 to 26.06.2017 and on the last date of filing claims and objections 28.06.2017 there was rain on whole day and has received only four objections, and further requested to extend the time for filing the claims and objections by one week.

3. In view of request of the Sub Divisional Officer (Civil), Barara , the State Election Commission, in exercise of powers conferred in Section 3A of the Haryana Municipal Act, 1973 read with rule 4 of Haryana Municipal Election Rules, 1978, hereby revise the schedule for preparation of ward wise and booth wise photo based electoral rolls in respect of all the wards of the Municipal Committee, Barara as given under :-

(i)	Last date by which claims and objections shall be presented to the Revising Authority. [Rule-4(4)(i)]	06.07.2017
(ii)	Last date by which the claims and objections shall be disposed of by the Revising Authority. [Rule-4 (4) (v)& (vii)]	14.07.2017
(iii)	Last date for filing appeals with the Deputy Commissioner against the orders of Revising Authority. (Rule-4 (4) (viii)]	18.07.2017
(iv)	Last date for disposal of appeals by the Deputy Commissioner.[Rule 4(4) (viii)]	21.07.2017
(vi)	Final publication of Electoral Rolls.(Rule-4 (4) (ix)	27.07.2017

4. The Deputy Commissioner, Ambala shall give wide publicity of the above programme.
5. The remaining instructions issued earlier by notification No. SEC/2ME/2017/1167, dated 08.06.2017 shall remain unchanged.
