
I am directed to refer to the subject cited above and to inform you that this Commission has issued the programme for the conduct of the General Elections of the seat of Mayor and members of all the wards of Municipal Corporation, Ambala, Panchkula & Sonapat and President and Members of Municipal Council Rewari, Municipal Committee, Sampla (Rohtak), Dharuhera (Rewari) & Ukalana (Hisar) and Bye- elections of W. No. 07 of Municipal Committee, Indri (Karnal), W. No. 13 of Bhuna (Fatehabad), W. No. 12 of Rajound (Kaithal), W. No. 14 of Municipal Council, Fatehabad and W. No. 29 of Municipal Council, Sirsa vide Notification No. SEC/1ME/2020/3165 and SEC/1ME/2020/3184 dated 03.12.2020 (copies enclosed), respectively. With the announcement of election programme, Model Code of Conduct has come into operation immediately in the areas of municipalities where poll is to be held and shall remain enforced till the completion of election.

2. The Commission has earlier noticed that despite the fact that the Model Code of Conduct only remains effective in the areas where poll is to be held, several Govt. Departments, semi Government Departments, Boards, Corporations, Universities etc. approach this Commission for relaxation on separate issues, issuance of NOC, permission etc.

3. The Commission therefore makes it clear that the Model Code of Conduct remains effective only in the areas where poll is to be held and not outside the areas.

4. I am, therefore, directed to request you to bring it into the notice of all the offices under your control that the model code of conduct is only effective in the areas of municipalities where poll is to be held and as such, the matters pertaining to the other Urban/Municipal areas may not be sent to this Commission for any kind of relaxation, issuance of NOC, permission etc.
