Sir,

I am directed to refer to the subject cited above and to say that the State Election Commission, Harvana has issued the notifications for the conduct of the General Elections of the seat of Mayor and members of all the wards of Municipal Corporation, Ambala, Panchkula & Sonepat and President and Members of Municipal Committee, Sampla (Rohtak), Dharuhera Municipal Council Rewari, (Rewari) & Ukalana (Hisar) and Bye- elections of W. No. 07 of Municipal Committee, Indri (Karnal), W. No. 13 of Bhuna (Fatehabad), W. No. 12 of Rajound (Kaithal), W. No. 14 of Municipal Council, Fatehabad and W. No. 29 of Municipal Council, Sirsa vide Notification No. SEC/1ME/2020/3165 and SEC/1ME/2020/3184 dated 03.12.2020 (copies enclosed), respectively. As per schedule, the nomination papers shall be presented from 11.12.2020 to 16.12.2020 and poll shall be held on 27.12.2020. Re-poll if any required, shall be held on 29.12.2020 and counting of votes shall be held on 30.12.2020 at 8.00 A.M. at the place(s) specified by the Deputy Commissioner concerned and result shall be declared immediately after the completion of counting.

2. As per Section 8D of the Haryana Municipal Corporation Act, 1994, and Section 13D of the Haryana Municipal Act, 1973, the provisions given under Section 28A of the Representation of the People Act, 1951 are to be mutatis mutandis applied in municipal elections. The provisions given under Section 28A of the Representation of the People Act, 1951, are reproduced here as under:-

"28A. Returning officer, presiding officer, etc., deemed to be on deputation to Election Commission. The Returning Officer, Assistant Returning Officer, Presiding Officer, Polling Officer and any other officer appointed under this part, and any Police Officer designated for the time being by the State Government, for the conduct of any election shall be deemed to be on deputation to the Election Commission for the period commencing on and from the date of the notification calling for such election and ending with the date of declaration of the results of such election and accordingly, such officers shall, during that period, be subject to the control, superintendence and discipline of the Election Commission".

**3.** In view of the above, I am, therefore, directed to request you to bring these provisions into the notice of all concerned for information and compliance.
